22/92/1 - REPAIR

Members noted the repair of the height restriction barrier and the installation of a height restriction warning sign.

22/93/1 - ELECTRICITY STATEMENTS

Members noted electricity statements (estimated) for the period 3 November 2022 to 2 January 2023 and that the account is £39.78 in debit. The Clerk reported that she had recently submitted a meter reading to the energy supplier and that the actual reading was lower than the estimated reading.
