MINUTES OF THE MEETING HELD ON THURSDAY 2 MARCH 2023

The meeting opened at 7.17pm and was chaired by the chairman, Cllr J A Crossley.

21/272 - PUBLIC FORUM

- (a) A resident requested an update regarding Cllr J A Crossley's correspondence concerning footpath no. 3. Cllr J A Crossley reported that he had emailed again restating his original query (as regards the legal status of defined user rights on a private road bisected by a public highway and the separation of a footway). He had received a response that the developer would not install a separate footway on FP no.3 as this was not part of the planning condition for the development. Cllr J A Crossley posited that if the problems continued after the adoption of the public highway on Davy Avenue, it may require a request to Leeds City Council highways department to find a solution, as the problem had been caused by a lack of consideration at the planning stage.
- (b) The footpath in the Daisy Banks area stops at the playground and isn't a suitable replacement for the public right of way that was lost due to development.
- (c) A resident reported that the school had not been aware of the new footpath due to be created on the west side of Great North Road (from the New Path to the Blands Arms). He suggested that the Parish Council acts as a liaison with the school to keep it up-to-date.
- (d) A resident asked what had happened to the pub sign. Cllr N Duff reported that to the best of his knowledge, the brewery had removed the sign.
- (e) A resident reported that the police had become involved in the problems with footpath no. 3 and would take up the issue with Leeds City Council.

22/287/2 - DISPLAY REVISION

RESOLVED by unanimous vote to approve a revision to the intended festive display south of the railway bridge, so that there will be a total of 6 street light motifs and no street tree displays.

RESOLVED by unanimous vote to approve an additional sensor unit (isolator and sensor-type control equipment with electrical cable and high level socket) to the intended number for the street lighting columns south of the railway bridge, so that there would be a total of 4 new sensor units, instead of the previously agreed 3.

RESOLVED by unanimous vote to approve the intention to install 4 sensor units to street lighting columns 65G293, 67G293, 71G293 and 73G293 on the Great North Road south of the railway bridge.

RESOLVED by unanimous vote to approve the intention to hire 6 wrap-around street light motifs to street lighting columns 65G293, 67G293, 71G293 and 73G293, and also 69G293 and 76G293 (where the sensor units are already in situ).

22/287/6 - LEEDS LIGHTS PRICES

Members noted that the new prices for 2023 would not be available from Leeds Lights until late March.

22/287/7 - GRANT: HOOK MOOR WIND FARM

Proposed by Cllr E A Robertson Seconded by Cllr R M Czwarno

RESOLVED by unanimous vote to approve that the application to the Hook Moor Wind Farm Fund be revised to seek a grant to cover the full cost of the supply and installation of a total of 11 sensor units to street lighting columns (4 south of the railway bridge, the previously agreed 3 opposite Garden Village bankings and the previously agreed 2 on Churchville Drive and 2 on Churchville Terrace.

22/287/8 - CHRISTMAS TREES AND LIGHTS

Proposed by Cllr J A Crossley Seconded by Cllr R M Czwarno

RESOLVED by unanimous vote to approve the intention to provide 2 Christmas Trees (15 feet high) with 30m strip lights for each tree (one at Churchville House and one at Garden Village bankings), hire 2 wrap-around street light motifs on Churchville Drive and 2 wrap-around street

light motifs on Churchville Terrace, and to continue with the long-established hire of strip light displays in the 2 street trees on the Great North Road north of the railway bridge and in the 2 street trees on Church Lane.

22/287/9 - GRANT: OUTER EAST COMMUNITY COMMITTEE

Proposed by Cllr J A Crossley Seconded by Cllr R M Czwarno

RESOLVED by unanimous vote to approve submitting an application to the Outer East Community Committee for a grant to cover the full cost of the supply of the 2 Christmas trees and the hire of 30m of strip lights for each tree.

22/287/10 - FUNDING FAILURE

Members noted that if either or both grant applications do not succeed, the Parish Council will need to reassess the actual festive display that it will provide for Christmas 2023.

22/288 - HIGHWAYS AND FOOTPATHS

22/288/1 - YELLOW LINES REQUEST

Members noted a resident's exchanges with Leeds City Council Kippax and Methley ward members regarding a request to mark yellow lines on Church Lane in front of Radford Meadows (Avant Homes Development) to prevent obstruction of the highway by parked cars.

22/288/2 - SUPPORT REQUEST

Proposed by Cllr J A Crossley Seconded by Cllr R M Czwarno

RESOLVED by unanimous vote to support the request to Kippax and Methley ward councillors for double yellow lines on Church Lane in front of Radford Meadows (Avant Homes Development) to prevent obstruction of the highway by parked cars.

22/288/3 - CLAIMED FOOTPATH

Members noted the difficulties experienced by users of the claimed footpath from St Mary's Walk to the new development (Radford Meadows – Avant Homes).

22/288/4 - ACTION TAKEN

Members noted action already taken to help resolve the difficulties: Cllr E A Robertson had spoken to the site manager again and hard core had been laid on the path, although the land level difference between the footpath and the properties to the north was still a problem. Cllr J A Crossley had contacted Leeds City Council planning services to query the alignment of the footpath.
