#### 23/51/2 - PERIMETER FENCE IMPROVEMENTS

RESOLVED by unanimous vote that the Parish Council can undertake improvements to the football pitch perimeter fence as part of its CIL recreation ground improvements.

#### 23/52/1 - ENTRANCE SIGN

Members noted that there was no update on the provision of an entrance sign.

#### 23/52/2 - VEGETATION MAINTENANCE

Members discussed the maintenance needs of the vegetation around the enclosed car park inner perimeter.

RESOLVED by unanimous vote to strim the inner perimeter back to the fence on all three sides and cut the laterals that extend beyond the fence, back to the fence; to be undertaken by Aire and Calder Ltd. as a one-off priced job.

#### 23/53/1 - 'NO PARKING' SIGNS

Members noted that there was no update on the provision of 'No Parking' signs on the access gates on Lower Peckfield Lane.

#### 23/54 - ACCESS

#### 23/54/1 - SCHEME

Cllr J A Crossley gave an update on the Parish Council's Strategy group meetings and the group's querying the need for a chicane to prevent quads, when they were already able to access the ground in other ways. A chicane would only be needed if all areas accessible to quads were made inaccessible. Proposed by Cllr J A Crossley

Seconded by Cllr P Meir

RESOLVED by unanimous vote to inform the Parish Council that a chicane-based inclusive access control is not necessary as quads and bikes access the ground through the existing gaps.

#### 23/55 - MUGA/WILDFLOWER MEADOW

#### 23/55/1 - MUGA

The Clerk gave an update on the condition of the MUGA, which had not changed.

#### 23/55/2 - WILDFLOWER MEADOW

Members noted that the annual cut of the wildflower meadow had been undertaken

RESOLVED by unanimous vote that the whole scope of the works required to remove the existing shelter and install a new three bay double sided shelter are undertaken by the Parish Council as part of its CIL seating shelter project.

RESOLVED by unanimous vote to approve an increase in the play equipment provided by the addition of equipment suitable for toddlers and young children in the triangular area between the swings and entrance [to/from car park] with a fence around.

RESOLVED by unanimous vote that the whole scope of the works required to increase play provision are undertaken by the Parish Council as part of its CIL toddler play project.
